

## **TERMS OF USE**

These terms of use ("Terms of Use") governs the access and use of Publishwise ("Publishwise"), by users (hereinafter referred to as "You" or "Your" or "Yourself" or "User"). Your use of Publishwise constitutes Your agreement to all the terms, conditions and restrictions contained in these Terms of Use.

YOU SHOULD CAREFULLY READ THE FOLLOWING TERMS OF USE BEFORE USING PUBLISHWISE AS THEY CONSTITUTE A BINDING LEGAL AGREEMENT BETWEEN YOU AND EVALUESERVE ("Us" or "We").

IN ADDITION TO THESE TERMS OF USE, USE OF PUBLISHWISE BY YOU SHALL BE GOVERNED BY THE APPLICABLE PROPOSAL, STATEMENT OF WORK, ORDER FORM OR ANY OTHER LIKE DOCUMENT ("TERMS OF LICENSE") AS MAY BE AGREED WITH US.

### **1. General**

Publishwise is an Internet based portal owned and operated by Evalueserve. Your use of Publishwise and Your access to it is subject to, and is conditional upon you accepting, all of the terms and conditions contained in these Terms of Use. All rights in this Publishwise are owned by Evalueserve, and any unauthorized use, copying or modification is prohibited.

### **2. User Account, Password, and Security**

- a. To use Publishwise, you must be at least 18 years old or have reached the age of majority in your jurisdiction. By accessing Publishwise, you affirm that you meet this eligibility requirement.
- b. Evalueserve may make certain Services available to You through Publishwise only if You have provided Evalueserve with such User information as may be requested by Evalueserve. The account created by Evalueserve for You ("Account") can be accessed by a user ID and password provided by Evalueserve (collectively, the "Account Information"). Publishwise requires You to log in as a User using the Account Information to make use of the Services provided by/ through Publishwise. - b. Your use of the Services, and all terms relating to Your purchase of the Services and materials, are subject to the Terms of License. If there is any conflict between these Terms of Use and the Terms of License, the Terms of License shall prevail.
- c. Your use of Publishwise, the reports and/or materials may also be subject to additional procedures for use, uploaded

guidelines, rules, terms of service, disclaimers and notices, or any other additional terms and conditions as may be notified to You by Evalueserve from time to time ("Additional Terms"). - b.
